Control and Replenishment

Procedure

1. Pipet 1.0 ml sample solution of Equipment Cleaner 60 into a 250 ml erlenmeyer flask.
2. Dilute to 75 ml with DI water
3. Add 5-10 drops methyl red indicator.
4. Titrate with 1.0 N sodium hydroxide to faint orange color solution.
5. If it takes less than 5.0 ml of 1.0N sodium hydroxide, the solution will become ineffective.
